ANNOUNCEMENT ON WAIVING QUARANTINE FOR ALL NON-VACCINATED OR NON-FULLY VACCINATED TRAVELERS

In accordance with the decision of the Royal Government of the Kingdom of Cambodia, the Ministry of Tourism is pleased to notify tourism operators, domestic tourists, international tourists, media and the public that the quarantine requirements will be waived for all travelers who have not been vaccinated or have partly been vaccinated against Covid-19 from 11 July 2022 with the following condition:

- Required to take COVID-19 Rapid Test by health officer upon arrival in Cambodia and foreigners shall pay a test fee of US \$ 5 per person.
 - In case of a negative test result: the travelers are allowed to continue his / her journey to his / her home or destination throughout Cambodia without quarantine.
 - In case of a positive test result and a mild disease: must be treated in accordance with Standard Operating Procedures for the Management, Care and Treatment of Covid-19 Patients at Home and he/she is responsible for all accommodation costs.
 - All travelers with a suitable residence can be isolated and treated at his / her home.
 - All travelers who does not have a suitable home to stay must be isolated and treated at a place designated by the Ministry of Health or the competent authority.
 - In case of serious disease: he/she has to receive Covid-19 treatment at the hospital, where the Covid-19 treatment service is integrated into a Single Health Care System. For Covid-19 patients who are foreigners, they have to pay for their own medical treatment and accommodation.
- All Travelers, who have not been vaccinated against Covid-19 for any reason, are encouraged to go to the vaccination sites in the capital and provinces without any charge.

All domestic and international tourists and travelers are required to strictly adhere to the "3 Do's 3 Don'ts" health measures as well as Standard Operation Procedures (SOPs) that the Ministry of Tourism has applied to all tourism services.

The Ministry of Tourism calls on all relevant parties to effectively implement and disseminate this Announcement to attract more international visitors to "Cambodia – Kingdom of Wonder, Feel the Warmth - Safe Clean and Green".

ANNOUNCEMENT

In reference to the Decision of the Royal Government of Cambodia, the Ministry of Tourism of the Kingdom of Cambodia has the great honor and is delighted to inform all tourism stakeholders, national and international tourists, and travelers, who have been fully vaccinated and traveling to the Kingdom of Cambodia, that as of 17th March 2022, the Royal Government of Cambodia has officially decided as follows:

- Waiving the requirement for the Negative 72-hour certificate of COVID-19 PCR Test Result prior to arrival in Cambodia.
- 2. Waiving the requirement for Antigen Rapid Test upon arrival.
- Reopening the Visa On Arrival service for all international travelers by air, land and sea by meeting the immigration requirements as previously implemented prior to the global pandemic of COVID-19.

Upon the arrivals all tourism stakeholders, national and international tourists, and travelers must present vaccinated cards recognized by their respective health authorities. For those, who have not been vaccinated, are still eligible to request/apply for Visa on Arrival; but subject to 14-day state quarantine at the locations designated by the Ministry of Health or respective/local authorities.

All tourism stakeholders, national and international tourists, and travelers are encouraged to conduct their own Antigen Rapid Tests before or upon arrival and during their stay in Cambodia; and must comply with the implementations of 3 DOs and 3 DON'Ts as well as all the Standard Operating Procedures (SOPs) in the Tourism Industry implemented by the Ministry of Tourism of the Kingdom of Cambodia.

The Ministry of Tourism requests all relevant tourism stakeholders to implement and disseminate this announcement effectively from today onward.

ADDITIONAL ANNOUNCEMENT

On Arrangements of International Air Travelers Detected with Positive Case of COVID-19 by Antigen Rapid Test

The State Secretariat of Civil Aviation (SSCA) of the Kingdom of Cambodia presents its compliments to all local airlines of Cambodia, foreign airlines, and commercial private jets (air operators) operating into and out of Phnom Penh, Siem Reap, and Preah Sihanouk International Airports (PNH/REP/KOS), and would like to update the latter on the latest arrangements of international air travelers who are detected with positive case of COVID-19 by Antigen Rapid Test upon arrivals as follows:

- 1. All air travelers entering the Kingdom of Cambodia shall strictly follow the latest Announcement dated 21 January 2022 by Ministry of Health, annexed to this additional announcement.
- 2. For clarity,
 - i. In case of a Negative Antigen Rapid Test of COVID-19 upon arrival, air travelers are allowed to travel across the Kingdom as normal. The unvaccinated or not fully vaccinated passengers shall go through the 14-day quarantine.
 - ii. In case of a Positive Antigen Rapid Test of COVID-19 upon arrival, further test of COVID-19 by PCR and Sequencing is required.
 - *iii.* All air travelers are allowed to get COVID-19 treatments at destinations at their choosing (such as hotel, embassy residence, house, etc.) without having to get treatments at only public hospitals or treatment centers.
- 3. Noted that other travel restrictions and measures in relation to COVID-19 specified under NOTICE (Revision 11) dated 17 November 2021 remain in force.

The State Secretariat of Civil Aviation (SSCA) of the Kingdom of Cambodia presents its compliment to all local airlines of Cambodia, foreign airlines, and commercial private jets (air operators) operating into and out of Phnom Penh, Siem Reap, and Preah Sihanouk International Airports (PNH/REP/KOS) and would like to update the latter on the latest revised measures for prevention, containment, and response to the spread of the COVID-19 as issued by the Royal Government of Cambodia, as follows:

- 1. All air travelers who wish to enter the Kingdom of Cambodia MUST strictly follow the latest Decision on the Revision of Requirements for Travels, Implementation of Health Measures and Quarantines for Travelers Entering Cambodia in the Context of New Normal Trajectory dated 16 November 2021, Ref: 504 S.K.L as an Annex 1 to this Notice.
- 2. For clarity,
 - A. Fully Vaccinated Passengers for COVID-19 (Both Cambodian and Foreign Nationals)
 - Certificate or Document Test for COVID-19 negative status (PCR) with the validity within 72 i. hours upon arrival in Cambodia
 - Proof of Certificate or Document of Vaccination ii.
 - iii. Rapid Test of COVID-19 upon arrival
 - a. Negative: No quarantine required
 - b. Positive: COVID-19 treatments
 - B. Unvaccinated or Not Fully Vaccinated Passengers for COVID-19 (Both Cambodian and **Foreign Nationals**)
 - Certificate or Document Test for COVID-19 negative status (PCR) with the validity within 72 i. hours upon arrival in Cambodia
 - ii. Booking hotels for self-quarantine or Deposit with 2,000 United States Dollars for quarantine arranged by local authorities (ONLY FOR FOREIGN NATIONALS) iii.
 - Rapid Test of COVID-19 upon arrival:
 - a. Negative:
 - 14-day guarantine
 - Retest of COVID-19 by PCR on 13th day of quarantine
 - b. Positive: COVID-19 treatments

C. Visa Application (Foreign Nationals)

- Visa Application through the Embassy or Consulate of the Kingdom of Cambodia i.
- Not available for Visa on Arrival, excepted, traveler holding the passport of country which ii. has an agreement with the Kingdom of Cambodia for Visa Exemption as Annex 2
- D. Responsibilities of Expenses for COVID-19 Treatments in the Case of Foreign Nationals:
 - Diplomats and Officials of International Organizations holding Visa A and Visa B: Selfresponsibilities of expenses for COVID-19 treatments
 - Other Foreign Nationals: Encourage, but not COMPULSORY, to purchase health insurance ii. for expenses of COVID-19 treatments (COVID-19 Health Insurance Policy) through https://www.forteinsurance.com/covid-19-insurance/.
- E. For Air Operators' Crews Who Are Entering the Kingdom of Cambodia: Refer to Attached Letter Ref: 179 dated 14 August 2020 issued by the Ministry of Health as ANNEX 3.
